

# UltraSolid **SAFETY COVER** LIMITED WARRANTY

#### **10 YEAR LIMITED WARRANTY**

Garrett Covers, Inc. warrants to the original consumer purchaser this solid safety cover against separation of sewn seams when properly ordered, installed, used, and maintained, for a period of 10 years.

Within 24 months from factory shipping date, Garrett Covers, Inc. will repair or replace at our option, free of charge (exclusive of freight charges), any component part or parts which to our satisfaction proves defective.

After the 24<sup>th</sup> month, Garrett Covers, Inc. will repair or replace any such defective component; but the purchaser shall pay a pro-rated portion of the cost. This pro-rated portion is the then-current retail price of the cover, less 1/120 of the price for each full month remaining in the warranty period.

All repairs or replacements shall be F.O.B. Garrett Covers, Inc. plant. **EXCLUSIONS** 

- This warranty is not valid if the cover has been improperly installed or subject to misuse, alterations, neglect, or abuse, or if the water level of the pool falls more than 18 inches below the pool coping during snow season.
- This warranty is not valid if this cover is installed on a size or shape of pool other than that for which it was designed, such as using a rectangular cover on a freeform pool.
- This warranty does not cover accidental damage or acts of nature, such as:
  - □ Tree limbs or other sharp objects piercing the cover.
- Animal damage.
- □ Fading of materials due to sun or chemical exposure.
- □ Abrasion from excessive wind moving cover, or abrasion from pool coping.
- □ Cigarette burns.

#### **CLAIM PROCEDURE**

- 1. If you believe that you have a claim under this warranty, write, fax, or call our Customer Service Department.
- 2. If the cover is to be returned to us, you will be given an RGA number.
- 3. When returning the cover, it must be clean and dry, and all springs and other hardware removed. Return only the component that is at fault.
- 4. Enclose the following in a separate envelope attached to the outside of the carton:
  - The RGA number.
  - A copy of the sales receipt, as proof of purchase.
  - A description of the nature and location of the problem.
  - Your return shipping address and daytime telephone number.
- 5. Return to the factory freight prepaid. Collect shipments will be refused. (UPS is generally most economical.)
- 6. In order to ensure a timely return to you, we must receive your cover by July 1.

Garrett Covers, Inc. will not be liable for the costs of freight, installation, service or labor costs, or other incidental or consequential damages.

This warranty is in lieu of any other warranty, expressed or implied, and we neither assume nor authorize anyone else to assume for us any other obligation or liability.

This warranty gives the original consumer purchaser specific legal rights. Purchaser may also have other rights which vary from state to state.
